These categories reflect uniform definitions formulated by the National Center for Injury Prevention and Control, in "Sexual Violence Surveillance: Uniform Definitions and Recommended Data Elements," and Centers for Disease Control and Prevention. The categories of youth-on-youth SEXUAL VIOLENCE are:

#### NON-CONSENSUAL SEXUAL ACTS:

Contact of any person without his or her consent, or of a person who is unable to consent or refuse; **AND OR**

- Contact between the mouth and the penis, vagina, or anus; **OR**
- Penetration of the anal or genital opening of another person by a hand, finger, or other object.

#### ABUSIVE SEXUAL CONTACTS:

Contact of any person without his or her consent, or of a person who is unable to consent or refuse; **AND**

- Intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or buttocks of any person. Exclude incidents in which the intent of the sexual contact is to harm or debilitate rather than sexually exploit.

Sexual relationships of a romantic nature between staff and youth are included in this definition **OR**

- Completed, attempted, threatened; or requested sexual acts; **OR**
- Occurrences of indecent exposure, invasion of privacy, or staff voyeurism for sexual gratification.
- Intentional touching of the genitalia, anus, groin, breast, inner thigh, or buttocks with the intent to abuse, arouse, or gratify sexual desire;

Consensual or non-consensual sexual acts including:

- Completed, attempted, threatened, or requested sexual acts; **OR**
- Occurrences of indecent exposure, invasion of privacy, or staff voyeurism for sexual gratification.

#### **DEFINITION OF STAFF SEXUAL HARASSMENT**

The definition of STAFF SEXUAL HARASSMENT was also developed by the National Institute of Corrections.

**STAFF SEXUAL HARASSMENT:** includes repeated verbal statements or comments of a sexual nature to a juvenile or youthful offender by an employee, volunteer, contractor, official visitor, or other agency representative (exclude youth family, friends, or other visitors);

**OR**

- Repeated profane or obscene language or gestures; **OR**
- Demeaning references to gender or derogatory comments about body or clothing;
